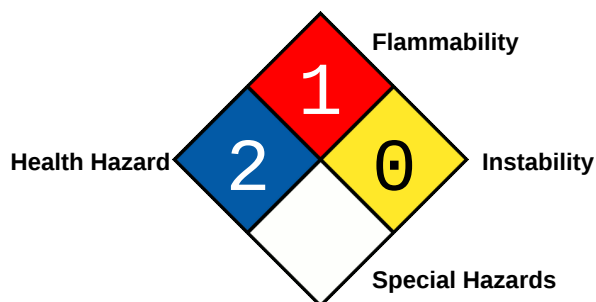

16.1 Additional information

WORK PRACTICES - SOLVENTS: Organic solvents may present both a health and flammability hazard.
